- III. OLD BUSINESS (action if appropriate)
  - A. Administrative Proposal: For the 2016-17 school year, the Co-curricular Code be changed so that School Board contracts with an Independent Investigator for all code violations. If any code violations are reported to administration, then administration would call this Independent Investigator and the Independent Investigator would proceed with the investigation, determine outcome, and assign

the appropriate consequences per the code. There would be one appeal step to the School Board and this would be final.

- B. High School Faculty proposal to change language in Student Handbook: Proposed Student Cell Phone and Electronic Device Changes for the 2016-2017 School Year; Includes all electronic devices except school issued devices such as Chromebooks.
  - 1. When can a student use a cell phone or electronic device?:
    - a) Electronic devices may be used before school, during lunch period, and after school.
  - 2. Cell Phone/Electronic Policy:
    - a) No possession or use during any class periods during the regular school day, including but not limited to:
    - b) No possession or use in the classroom, library, and homeroom
    - c) No use in the hallways in between classes
    - d) No use in the locker room or coach's office
    - e) No use in "Closed Campus" due to disciplinary action
    - No use in after school detention, or in After Hours if student is there for failing grades
    - g) No use during assemblies unless prior approval by staff or administration
    - h) No use of earbuds in the hallway or classroom unless prior approval by staff or administration
  - 3. Consequences:
    - a) Step 1: Staff may confiscate and send the electronic device to the office. Student picks up the device in the office after school.
    - b) Step 2: Staff may confiscate and send the electronic device to the office. Student will need to turn the device into the office at the start of the school day. (1 Week) If not, the student may be moved to Step 5.
    - c) Step 3: Staff may confiscate and send the electronic device to the office. Student will need to turn the device into the office at the start of school day. (9 weeks) If not, the student may be moved to Step 5.
    - d) Step 4: Staff may confiscate and send the electronic device to the office. Student will need to turn the device into the office at the start of school. (Semester) If not, the student may be moved to Step 5.
    - e) Step 5: Staff may confiscate and send the electronic device to the office and it will be returned to the parent/guardian only. The student will need to turn his/her electronic device into the office on a daily basis for the remainder of the school year.
