 - After the referendum funds (\$18.9 million) are depleted (fund 49), there is a remaining balance of \$852,516 to be paid out.
 - Available Monies on Hand
 - Fund 41 (Building Fund) \$480,000

 - Fund 10 Direct Deduction \$1.73 million in Fund 10
 - Possible Borrowing Scenarios

- The District can have accumulated debt up to \$1 million in any given year not encumbered by referendum, similar to line of credit we passed earlier this school year. The difference of carrying a note is we have to count the balance of the note against the \$1 million annually and only able to borrow the difference between the loan balance and the \$1 million limit. Each year we pay down the debt, the more we are allowed to borrow in that year as long as it does not exceed \$1 million.
- Not in Project Budget Items
 - Need to be realistic on things we can raise money for and things we need to budget for longer term.

■ Budget Work

- o \$204 per pupil INCREASE for 18-19
- Capital Purchases Limit for 18-19
 - It would be wise to be conservative on major Capital Purchases that are NOT NEEDED for the 18-19 School Year.
