- A. 2016-2017 year-end figures and present the Proposed Budget for 2017-2018 by Mr. Smudde and Mrs. Waller
- VI. TRUST FUND 73 (Funds held in trust for Employee Post-Employment Benefits)
  - A. \$551,277.05 is the amount in the trust fund as of June 30, 2017.
  - B. \$8,899.83 is the investment return earned between July 1, 2016 and June 30, 2017.
  - C. \$206,941.85 is the total deposits made between July 1, 2016 and June 30, 2017.

- D. \$41,328.68 is the total of disbursements made between July 1, 2016 and June 30, 2017.
- E. Mid America A & R Solutions, Inc. David Branback, Representative Lakeland, Florida is the name of the investment manager
- VII. CAPITAL EXPANSION FUND 41 (This is available for future capital expenditures for building and sites.)
  - A. \$480,058.83 is the amount in the fund as of June 30, 2017.
- VIII. QUESTION AND ANSWER.
- IX. BOARD APPROVAL OF FINAL BUDGET
  - A. BE IT RESOLVED, that the Prairie du Chien Board of Education approves the 2017-2018 fiscal year budget and property tax rate. Adoption of a tax levy: The school board approves to set the levy to a total tax of \$5,585,238 of which \$4,278,247 is for operations and \$1,306,991 is for debt. This amount does not exceed the maximum amount allowed under section 212.91 of the Wisconsin Statutes. Authority: Sections 120.10 (8) and (9), Wisconsin Statutes.
  - This Budget consists of the School Board making the commitment to engage in the Teacher Compensation Model and increase all Non-Teaching Staff salaries by 1.5% for the 2017-18 school year.
  - With payment of the salaries in two retroactive payments of ½ increase on December 15th, 2017 payroll and ½ increase the first payroll in July 2018.
    (Note: Discussion on having two payments or just one full retroactive payment in July 2018 were considered and voted on).

Motion by Gilberts to approve 2 payments retroactive, seconded by Panka. Passed 4-3 (Yes: Panka, Gilberts, O'Kane and Kozelka) (No: Hubanks, Achenbach and Rogers) Note: The "No" votes did approve the raise, they just wanted the one retroactive payment in July 2018.
