(a)Teachers Union PEA Negotiations Update: two final options/offers were submitted to the PEA through the WERC Mediator.

- a. 4.0% package, with minor language adjustments
- b. 4.0% package, with the same minor language adjustments, plus a language change to the layoff language to benefit teachers by recognizing previous teaching within the last five years with an ability to bump to that position; the quid-pro-quo offer to this language is to clean-up and standardize overload pay to about \$27.00 per hour pro-rated by minute and a reduction in prep time to 60 minutes per day or a possible increase in teaching time for teachers by 19 or 30 minutes per day.
- c. If neither of these options are chosen by the PEA, the arbitrator may send a letter of impasse which will most likely lead to a 3.8% Board imposed QEO.
