1. Counselor Services Discussion

<u>Kristine Rutherford</u>- We say that we want to help children, but we don't want a counselor in the lower level and Bluff View. We pay to transport students on field trips, we pay for sports, we want to raise tests scores, but think we can do so without a counselor. Not talking about career counselors. Teachers can't do it all. A guidance counselor should be a priority. Other areas that can be cut find a guidance counselor????

<u>Gene Carlson</u>- Couselors are important!! We may not know what the link is between school and home, because maybe the teachers, Admin are not trained to identify what those links are. Counselors are trained to identify those links.

<u>Sue Boldt-David</u>- There are troubled students out there that need help. She worries about them, is not trained to deal with it all, but does the best that she can, along with all of the other teachers. <u>Jamie Wagar</u>- Two main roles of a counselor 1. Safety net and 2 parent liaison. There are different roles for guidance counselors, depending on the age of students and the issues that go with that age-group. Budget is tight, but can we hire a 50% counselor?

Drew Johnson_ Willing to set up a committee to research this. Not concvinced that the problems that students are having can be solved by a school guidance counselor. Can we contract out with the County for Social Work Services. Get data from Stephanie on her "take" on this issue. Cindy Sheetz- Stephanie Foster can't be there for all of the students. When she has tried to reach out to Stephanie to give a heads up on issues going on with her daughter, she has had a hard time connecting with her via phone. Drew said 2 years ago that he would review data, facts, statistics and I don't think that this has been done.

2. Final Layoff notices for budgetary and excess staffing reasons to Emily O'Brien and Nicholas Darnick
