 - (d) Purchase Avaya Full system for \$61,000. (CenturyLink)
 - (e) Table for further discussion could set time for a meeting to get further advice. Example: Gunderson Lutheran has offered to have their phone system experts talk to us as they are changing over to a VOIP system this summer.
