Possible Resolution:

Whereas, many Wisconsin Schools have language in their collective bargaining agreements that stipulates a specific health care provider and,

Whereas, this language makes it extremely difficult, in this time of swiftly rising health insurance premiums, to select a lower cost provider through competitive bidding or otherwise and

Whereas, this translates into excessive costs for health insurance premiums which diverts funds that could otherwise be used for the educational benefit of our students and,

Therefore, the Prairie du Chien Area School District goes on record in support of the passage of legislation that will make the identification of a named health care provider a prohibited subject of bargaining in labor contract negotiations.

Further, the Prairie du Chien Area School district goes on record in support of the Wisconsin Association School Boards (WASB) Health Care Bargaining goals:

- (a) The WASB supports legislation that would make the selection of health insurance providers a prohibited subject of bargaining and to grant school boards the unilateral authority to determine the health insurance provider(s) for their employees.
- (b) The WASB supports legislation to limit payments for public employee health insurance to the amount set for the state health insurance plan available to the affected municipality.
- (c) The WASB supports legislation requiring the Office of Commissioner of Insurance to annually publish relevant data, such as loss rates, for all pooled groups, including Wisconsin school district employees, no later than June 1 of each calendar year.
- (d) The WASB supports allowing school districts to enroll individual employee bargaining units and non-represented staff in a health care coverage plan offered by the state group insurance board.
